**Contracts**

Any contract which is made between you/your spouse/partner (or a body in which the relevant person has a beneficial interest) and the Town Council.

- a) under which goods or services are to be provided or works are to be executed; AND
- b) which has not been fully discharged.

Any land in the Town Council's area in which you or your spouse/partner have a beneficial interest (which **includes your home** if it lies within the Town Council's area)

Any licence (alone or jointly with others) to occupy land in the area of the Town Council for a month or longer.

**Corporate tenancies**

Any tenancy where (to your knowledge):

- a) the landlord is the Town Council; AND
- b) the tenant is a body in which you or your spouse/partner has a beneficial interest.

**Securities**

Any beneficial interest in securities of a body where:

- a) that body to your knowledge has a place of business or land in the area of the Town Council; AND
- b) either:
  - i) the total nominal value of the securities exceeds £25,000 or one hundredth of the total issued share capital of that body; OR
  - ii) if the share capital of that body is of more than one class, the total nominal value of the shares of any one class in which the relevant person has a beneficial interest exceeds one hundredth of the total issued share capital of that class.

**Membership of Other Bodies**


**Notification of Disclosable Pecuniary Interests, pecuniary interests, personal interests and disclosure of gifts and hospitality**

I understand that I must, within 28 days of becoming a Member or Co-opted Member, notify Wokingham Borough Council's Monitoring Officer of any Disclosable Pecuniary Interests, pecuniary interests and personal interests; and that any gifts or hospitality must be notified in writing within 28 days of receipt, and any changes to my declared interests, including changes to sensitive information, must be notified in writing within 28 days of the change.

I recognise and understand that it is a criminal offence to:

- Fail to notify Wokingham Borough Council's Monitoring Officer of any Disclosable Pecuniary Interest within 28 days of election
- Fail to disclose a Disclosable Pecuniary Interest at a meeting if it is not on the register
- Fail to notify the Town Clerk within 28 days of a Disclosable Pecuniary Interest that is not on the register that I have disclosed to a meeting
- Participate in any discussion or vote on a matter in which I have a Disclosable Pecuniary Interest
- Knowingly or recklessly provide information that is false or misleading in notifying Wokingham Borough Council's Monitoring Officer of a Disclosable Pecuniary Interest or in disclosing such interest to a meeting

and that any breach of these regulations in the above terms can be referred to the Police and/or the Director of Public Prosecutions for criminal proceedings.
