 - ii) if the share capital of that body is of more than one class, the total nominal value of the shares of any one class in which the relevant person has a beneficial interest exceeds one hundredth of the total issued share capital of that class.



Notification of Disclosable Pecuniary Interests, pecuniary interests, personal interests and disclosure of gifts and hospitality

I understand that I must, within 28 days of becoming a Member or Co-opted Member, notify Wokingham Borough Council's Monitoring Officer of any Disclosable Pecuniary Interests, pecuniary interests and personal interests; and that any gifts or hospitality must be notified in writing within 28 days of receipt, and any changes to my declared interests, including changes to sensitive information, must be notified in writing within 28 days of the change.

I recognise and understand that it is a criminal offence to:

- Fail to notify Wokingham Borough Council's Monitoring Officer of any Disclosable Pecuniary Interest within 28 days of election
- Fail to disclose a Disclosable Pecuniary Interest at a meeting if it is not on the register
- Fail to notify Wokingham Borough Council's Monitoring Officer within 28 days of a Disclosable Pecuniary Interest that is not on the register that I have disclosed to a meeting
- Participate in any discussion or vote on a matter in which I have a Disclosable Pecuniary Interest
- Knowingly or recklessly provide information that is false or misleading in notifying Wokingham Borough Council's Monitoring Officer of a Disclosable Pecuniary Interest or in disclosing such interest to a meeting

and that any breach of these regulations in the above terms can be referred to the Police and/or the Director of Public Prosecutions for criminal proceedings.
